

Raster® License Agreement

All purchases of Raster® Equipment are subject to the terms of this agreement. This agreement is made by and between ACCENT SIGNAGE SYSTEMS, INC., a Minnesota Corporation, having an address of 2322 Chestnut Avenue West, Minneapolis, MN 55405, U.S.A. (referred to as Accent Signage) and _____ a _____ (type of entity – Corporation, Partnership, LTD, Govt Entity, Individual, etc.) having a place of business at _____ (referred to as LICENSEE). This agreement goes into effect on the date of LICENSEE’s signature.

1. **LICENSEE’s Rights** – Accent Signage will supply LICENSEE with the technology and methodology of the purchased Raster® Equipment, the related user manual entitled “How to Creat Great-Looking Interior Signage” (referred to as Manual), and LICENSEE ordered Braille Raster® Spheres. If LICENSEE satisfies its obligations under this agreement, LICENSEE has the following rights:
 - a. LICENSEE may use the Raster® Equipment, the Manual, and the Braille Raster® Spheres to make and sell Braille sign products
 - b. LICENSEE may use the trademarks Raster® Braille, Raster® Pen, Auto-Raster®, and Braille Raster® Spheres and use the name “Accent Signage Systems, Inc.”, in LICENSEE’s advertising and promotional literature and electronic media to accurately refer to Braille signs produced by LICENSEE.
 - c. LICENSEE will be included on Accent Signage’s list of vendors approved to provide Raster® Braille signs.

2. **LICENSEE’s Obligations** –
 - a. LICENSEE recognizes that the Raster® Equipment is intended for use with the Raster® Spheres and according to the directions of the Manual. LICENSEE agrees that it will use the Raster® Equipment only with Braille Raster® Spheres purchased from Accent Signage, or an Accent Signage approved supplier, and will use the Raster® Equipment in accordance with the then current version of the Manual.
 - b. If LICENSEE violates any of the above obligations, all of the LICENSEE’s rights in section 1 above automatically terminate.

3. **WARRANTY AND WARRANTY LIMITATIONS** – Accent Signage has separately provided LICENSEE with a written limited one-year warranty from the time of purchase. LICENSEE agrees that ANY USE OF PRESS-FIT MEMBERS IN RASTER® EQUIPMENT OTHER THAN BRAILLE RASTER® SPHERES, OR ANY USE OF THE RASTER® EQUIPMENT INCONSISTENT WITH THE INSTRUCTIONS OF THE THEN CURRENT MANUAL, WILL VOID ANY AND ALL REPRESENTATIONS OF THE WARRENTIES COVERING THE RASTER® EQUIPMENT, IT USES, AND SIGNS PRODUCED BY ITS USE, WHETHER OR NOT SUCH WARRANTES ARE EXPRESSED OR IMPLIED.
