

General Warranty for Interior Signage

LIMITED WARRANTY: All signs manufactured by Accent Signage Systems, Inc. are guaranteed for a period of one (1) year from the date of shipment or of invoice, whichever occurs first, to be free of workmanship defects. During this warranty period, any Accent Signage Systems, Inc. signs shown to the satisfaction of Accent Signage Systems, Inc. to be so defective, will be replaced without charge, or Accent Signage Systems, Inc. may issue a credit in such amount as deemed reasonable.

In no event shall Accent Signage Systems, Inc. be responsible for claims beyond the replacement value of the defective signage or in any way liable or responsible for incidental or consequential damages of any kind, indirect, special, nor for labor, removal or re-installation costs.

If the problem is determined to be due to a flaw in design or specifications, this warranty does not apply. Interior Sign Products are sold with the understanding that the Purchaser has independently determined the suitability of such products for its purposes and environments.

This Limited Warranty does not cover losses that occur as a result of:

- Shipping, improper installation or maintenance.
- · Misuse or neglect.
- · Normal wear and tear.
- Vandalism.

NOTICE AND INSPECTION: If you believe the product may qualify for warranted defects, you may return the product, along with dated proof of purchase, to Accent Signage Systems, Inc., 2322 Chestnut Ave. West, Minneapolis, Minnesota 55405.

WARRANTY SERVICES: Prior to returning any product, the Purchaser is required to secure authorization from Accent Signage Systems, Inc. for the return. The paper fibers will get caught on the raised lettering. Warranty will be considered null and void if solvents or other harsh chemicals are used to clean signage. Accent Signage Systems, Inc. will not accept liability if any such products are used on signage.
